

City of Adel Aquatic Center

**Pool Use Informed Consent Agreement
Waiver of Liability (Minor)**

The State of Iowa declared a public health emergency on March 17, 2020 in connection with the COVID-19 pandemic. City aquatic center use was temporarily suspended. Subsequent state directives have allowed for aquatic center facilities to resume. Accordingly, the City of Adel (“City”) will resume open swim at the aquatic center beginning on July 6, 2020 through the end of the season in September 2020 (the “2020 pool season”).

The City is taking reasonable measures to prevent the spread of infection, including tracking and following applicable state and federal guidance. However, the possibility of transmission cannot be eliminated. The City cannot guarantee aquatic center users during the 2020 pool season will not become infected. Pool users must be aware of and acknowledge the risks before entering the aquatic center for pool use.

By initialing and signing this Informed Consent Agreement, you acknowledge, accept, and agree to the following during the 2020 pool season (**User and Parent/Legal Guardian Must Initial and Sign**):

____ Use of the aquatic center pool and facilities is purely voluntary.

____ I will not enter the aquatic center if any of the following apply:

- a. Any member of our household is exhibiting symptoms of illness, such as cough, fever, or shortness of breath.
- b. Any member of our household has been diagnosed with COVID-19 or has a suspected diagnosis of COVID-19.
- c. Any member of our household has spent time with another individual who has been diagnosed with COVID-19 or has a suspected diagnosis of COVID-19.

____ I am aware that I may be exposed to COVID-19 while using the aquatic center facilities. I understand that this exposure carries a risk of infection, serious injury, or death. I accept this risk. I understand this risk is present each and every time I choose to enter and use the aquatic center, including the pool and facilities, during the 2020 pool season.

____ I am voluntarily using the aquatic center facilities and I agree to assume any and all risks of infection, injury, or death, whether those risks are known or unknown, each and every time I choose to enter and use the aquatic center, including the pool and facilities, during the 2020 pool season.

____ I agree to follow all pool facility rules, including following social distancing protocol by keeping 6 feet away from those not in my immediate household.

____ I forever release the City from any liabilities, causes of action, lawsuits, claims, demands, or damages of any kind whatsoever that I, my children, assignees, heirs, guardians,

next of kin, spouse, and legal representatives have, or may have in the future, related to use of the City aquatic center facilities during the 2020 pool season.

I HAVE CAREFULLY READ THIS WAIVER AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE OF THE RISKS OF USING CITY AQUATIC CENTER FACILITIES DURING THE COVID-19 PANDEMIC. I AM AWARE THAT THIS FORM CONTAINS A RELEASE OF LIABILITY RELATED TO THE 2020 POOL SEASON.
